

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation pursuant to Chapter 504, The Code, adopt the following Articles of Incorporation:

I

The name of the corporation is **WC HYPE, Inc** This corporation is incorporated pursuant to Chapter 504A, The Code.

II

The period of duration of the corporation is perpetual.

III
